

# **Fund-in Options to KVB**



#### **Direct Entry**

The direct entry system is a means of making electronic payments, used extensively by consumers and businesses to initiate 'pay anyone' transactions using internet banking applications.

Telegraphic Transfer or telex transfer is an electronic means of transferring funds to bank accounts.

#### Note:

- 1. We only accept payments from the client's own bank account.
- 2. Please include deal number on transfers to our bank account for easier reference.
- 3. For the first time payments to a new payee, some banks may put a security hold of up to 24 hours.



The client can use NPP from any Australian bank account that supports NPP payments. Please make sure to add **Customer Reference** on the NPP payment screen. Please add the **Deal No** as the message or description depending on the bank's user interface. Please pay the **exact amount** for the payment to process correctly.

#### Note:

- 1. We only accept payments from the client's own bank account.
- 2. First payments may take 1-2 working days to clear depending on the client's own bank's NPP policy. Future payments should clear within 1 working day.
- 3. If the client's payment is not being confirmed by GCFX after 1 working day, the client may contact our customer service team or the client's sales representatives to check.
- 4. Payments above the client's daily limit will be delayed.
